Cancellation Policy

_____ Initial

- In the event you need to cancel your tournament, the Innisfail Golf Club requires adequate time to adjust.
- In the case that adequate time is not given, the following policy will be in effect:
 - 14 days or less - loss of deposit and a second payment of 25% of tournament green fees, cart and meal cost
 - 8 days or less - loss of deposit and a second payment of 50% of tournament green fees, cart and meal cost.

Deposit & Payment Information

_____ Initial

- \$1500 deposit for shotgun tournaments will be required at time of booking to guarantee your date. Tournaments are confirmed by receipt of this deposit. Deposits are non-refundable and non-transferable in the event of a cancellation unless your event is rescheduled for another date. The final invoice will be adjusted accordingly to your deposit.
- The Innisfail Golf Club will provide you with an invoice within 3 days following your event. Payment is due upon receipt of this invoice and may be paid by cheque (payable to the Innisfail Golf Club) or by credit card.

Weather

_____ Initial

- In case of cold or inclement weather, tournament play and meals must go ahead as scheduled unless the golf course is deemed unplayable by the club superintendent or club manager of the Innisfail Golf Club.
- If this is the case, you will be given alternative days of play. If an alternative date is not available, the tournament deposit will be refunded.

Damages

_____ Initial

- The tournament host is responsible for the actions of its participants and will indemnify the Innisfail Golf Club from all losses, damages and claims which it suffers or incurs as a result of any act or omission of these participants.
- The Innisfail Golf Club will not be responsible for any loss or injury suffered by any participant unless such loss or injury is caused by negligence or wrongful acts of the Innisfail Golf Club or its employees.
- The tournament host is responsible for any damages to power carts, the golf course, the club-house or any fixed property of the Innisfail Golf Club. Any lost or negligent damage to rental clubs will be charged to the individual or the tournament host (depending on who was responsible for the rental fee).

Minimum Participant

_____ Initial

- Shotgun events must have a minimum of 100 players or be subject to \$155.00 per player charges. If you request a shotgun and have participants “drop-out”, you will be responsible for those players.

Food & Beverage Conditions

_____ Initial

- All prices related to Food & Beverage items are subject to an 18% gratuity and 5% GST.
- All Food & Beverage, including Sponsored Holes, must be organized a minimum of 2 weeks prior to the tournament. NO last minute food & beverage will be permitted.
 - Groups showing up with product without prior approval will not be allowed to take their product onto the course
- All food & beverage items MUST be purchased from the Innisfail Golf Club. No outside food or beverages are permitted.
- Unconsumed food and beverages may not be removed from the premises.
- A maximum of 2 beverage holes and 1 food hole per nine will be permitted as per AGLC Regulations
- 3 hole setups per side are included free of charge, each additional hole setup will be charged \$25.00 up to \$100.00 depending on requirements.
- Staffing for any food & beverage hole setups will have a mandatory \$150.00 charge.
- Any food & beverage sponsors must be in attendance ONE hour prior to the start of the event.

Tournament Setup

_____ Initial

- All player lists/groups, hole prizes, contests, tournament hole signage must be submitted to the Innisfail Golf Club NO LATER than two (2) days prior to the event.
- Power carts with name tags will be set up ONE hour before your start time, barring any unforeseen circumstances.

Hole-In-One Insurance Policy

_____ Initial

- The Innisfail Golf Club will provide ALL Hole-in-One insurance, you will be notified of the hole and yardages depending on the course rotation on the day of your event.
- Hole Spotters MUST be in attendance ONE hour prior to the start of the event.
